Petition from Bob Sweeney, representing **Gays for Patsy** for a **Special Liquor License** for an event to be held on April 29, 2017, from 8 pm to 11 pm in the Town Hall Auditorium.

Elizabeth Lovati discussed her hope that the restaurant would be 'diner like' similar to the old Tips for Tops.

Public comments - Peter Flint and Phillip Wilson (neighbors) support the new business. However, they expressed concerns regarding noise from early deliveries, loud fans and loading/unloading of empty bottles.

Ms. Lovati addressed the issues:

- Delivery issues are hard to resolve timing and noise are always a nuisance,
- she is not sure of the age of fans and
- because of the 'diner like' atmosphere she doesn't expect the bar to be as busy as the business.

George Dunlop - 11 Pleasant Street - He indicated that he supports the new business but the fan noise was a issue.
