Discussion re: letter from owner of Red Inn in favor of Anthony's application

Anthony: Started working in restaurants at age of 12. For three years that I have been here in town I have had to go through the licensing process with the Red Inn. Have done entertainment for instance so I am familiar with the process. Now with Tin Pan Alley I have been through the process from the beginning. I think I am familiar with the process. Would like to take a more active role.

Kristin discusses quorum issues the board faces. Great when people know the process. You called the lawyer of the day to discuss any conflicts.

AJ: Allowed to vote on Common Vic and Alcohol?

Anthony: not a lot of guidance in the rules. Typically not supposed to vote on competitor. But what is that to me as the manager of Tin Pan Alley? Attorney said that restaurants that fit the same bill as what you do would be competitors. There is a disclosure form. Left up to the appointing board to determine what exactly the conflict is. There is a little grey there.

Kristin: I can tell you that in my opinion all the restaurants are your competitors. I went through the Select Board to determine the conflicts as I work for an establishment with a liquor license.

AJ: having the Selectmen clear you for voting makes it easy for us not to worry about voting

Kristin; I like to err on the side of over-caution. The problem is the appeal process

Discussion re: which position to put him into. One available to be appointed by the board

Anthony: I don't want to take the spot if it isn't helpful to the board.

AJ: I think appointing and sending him to the select board is the way to go.
