The Provincetown Historic District Commission will hold a Public Hearing at 4:00 P.M. on Wednesday, October 18, 2017, in the Judge Welsh Hearing Room, Town Hall, 260 Commercial Street, Provincetown, MA.

Public Hearings will be held for the following applications requesting a Certificate to be issued in accordance with the Provincetown Historic District Commission established under the General By-Laws, Chapter 15 of the Town of Provincetown.

Application by **Mark Kinnane, of Cape Associates**, on behalf of **Seamen's Savings Bank**, requesting to replace two windows, replace black shutters in kind and modify at ATM vestibule on the property located at **221 Commercial Street**.

Application by **Don DiRocco, of Hammer Architects**, on behalf of **Jason Moore**, requesting to remove and replace a second floor door on the east elevation, remove a second floor window and replace with a five-sided window on the north elevation and re-locate an existing second floor casement window on the west elevation of the structure at **105 Commercial Street, #2**.
